

**Revised Total Coliform Rule (RTCR) Failure to Report Monitoring Events to the State that are Not Related to *E. coli*-positive Sample Results – Template 3-5**

**IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER**

We are required to report the results of monitoring of your drinking water for specific contaminants on a regular basis by MAY 2019. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. In MAY 2019, we did not report the results of monitoring for total coliform. Our system failed to notify the state drinking water program as required by MAY 2019. Although public health was not impacted, as our customers, you have a right to know what happened and what we did to correct the situation.

**What should I do?**

There is nothing you need to do at this time. You do not need to boil your water or take other actions.

**What is being done?** Our corrective action is: In order to return to compliance, our system had to collect a current distribution sample take it to the lab and report the results to TCEQ and that sample was collected, and we returned to compliance as of 06/12/2019.
